RESOLUTION NUMBER R- 262213

ADOPTED ON DEC 17 1984

WHEREAS, it has long been the City Council's policy that property and capital improvements acquired with Community Development Block Grant (CDBG) funds be retained in City ownership; and

WHEREAS, it is not the City's intention to generate revenue from CDBG funds allocated to community groups for property acquisition and capital improvements; and


WHEREAS, on December 12, 1984 the Public Services and Safety Committee, by a 5-0 vote, directed the City Manager to prepare a City Council policy embodying this heretofore unwritten policy; and

WHEREAS, the City Council has allocated \$218,400 from the 1984 CDBG program to the Neighborhood Outreach Program for property acquisition and building renovation; and

WHEREAS, the City Manager is now seeking \$1,500 monthly rent pursuant to the published Council Policy No. 700-12 for such property and building rental pending adoption of the proposed policy above; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby directed to negotiate a lease with the Neighborhood Outreach Program at a nominal rate pending adoption of the aforementioned policy.
