RESOLUTION ORDERING THE DETACHMENT OF A PORTION OF THE PENASQUITOS EAST LANDSCAPE MAINTENANCE DISTRICT AND ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE IN THE MATTER OF THE PARK VILLAGE LANDSCAPE MAINTENANCE DISTRICT.

WHEREAS, the property owners have waived the noticing provisions pursuant to Streets and Highways Code Section 22608.1 and the legal time for filing protests and the hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.

2. The detachment of territory from the Penasquitos East Landscape Maintenance District, the exterior boundaries of which are described in said Resolution of Intention, is hereby ordered.

3. The District, the boundaries of which are described in said Resolution of Intention, is hereby ordered formed.

4. That except as provided in paragraph 5 of this resolution, the assessments described in Document No. **RR- 262490**, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.

5. The maintenance described in said Resolution of Intention is hereby ordered performed.
