ADOPTED ON JAN 7 1985

AN ORDINANCE AMENDING SECTION 2 OF EMERGENCY
ORDINANCE NO. O-16332, ADOPTED NOVEMBER 20,
1984, LIMITING THE ISSUANCE OF BUILDING
PERMITS AND COMMENCEMENT OF CONSTRUCTION OF
PROJECTS WITHIN COUNCIL DISTRICT 4.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Ordinance No. O-16332, adopted November 20,
1984, be, and the same is hereby amended by amending Section 2 to
read as follows:

Section 2. PROHIBITION

Within the boundary as indicated in Section 1
above, no building permit shall be issued for
construction of any structure unless:

A., B., C., D. - No change.


E. Except as provided for in subsections B and C
above, and also excepting those cases where a
permit application for an R-1 lot was filed with
the Building Department prior to November 20, 1984,
no permit shall be issued for the moving of
structures onto lots within District 4 (Municipal
Code Section 91.0510) or for the placement of
manufactured housing or mobilehomes on lots within
the ordinance subject area.

F. and G. - No change.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.

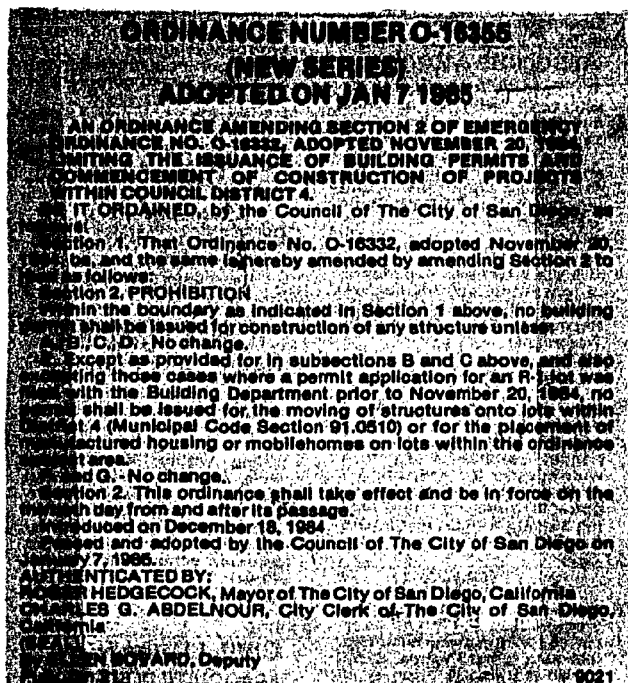
