AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. O-15805 (NEW SERIES), ADOPTED AUGUST 16, 1982, PREZONING A PORTION OF LOT 1, SUMMIT UNIT NO. 1, MAP NO. 6721, (APPROXIMATELY 13 ACRES), LOCATED SOUTH OF PARADISE VALLEY ROAD, BETWEEN BLUFFVIEW ROAD AND WARMWOOD AVENUE, IN THE COUNTY OF SAN DIEGO, CALIFORNIA, UPON ANNEXATION, INTO R1-5000 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. O-15805 (New Series), adopted August 16, 1982; and

WHEREAS, Section 1 of Ordinance No. 0-15805 (New Series) provided that the R1-5000 Zone would attach if a final map or maps were recorded on or before September 15, 1984, which is within two years of annexation of the property; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 0-15805 (New Series), adopted August 16, 1982, is hereby amended to read as follows:

Section 1. That upon annexation to The City of San Diego and in the event that on or before September 15, 1987 a portion of Lot 1, Summit Unit No. 1, Map No. 6721,

(approximately 13 acres), located south of Paradise Valley Road, between Bluffview Road and Warmwood Avenue, in the County of San Diego, California, within the boundary of the district designated "R1-5000" on that certain Zone Map Drawing No. B-3494.1, is subdivided and a final subdivision map or maps thereof are duly submitted to the City, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0407 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R1-5000 Zone, as described by Section 101.0407 of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3494.1, filed in the office of the City Clerk as Document No. 769052. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
