ORDINANCE NUMBER O- 16366 (NEW SERIES)

ADOPTED ON JAN 22 1985

AN ORDINANCE ESTABLISHING A NEW PARKING METER ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to the authority of Section 22508 of the California Vehicle Code and in accordance with the provisions of Chapter VIII of the San Diego Municipal Code, a parking meter zone is hereby established in the following location:

North side of Robinson Avenue from Alley
between First and Third Avenues to alley
between Third and Fourth Avenues; South side
of Robinson Avenue from Third Avenue to alley
between Third and Fourth Avenues.


The above described meters shall be in parking meter Zone A as described in Section 86.11 of the San Diego Municipal Code.

Section 2. A parking time limit of two hours shall be in effect in the above described location between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, as enumerated in Section 86.04 of the San Diego Municipal Code.

Section 3. The installation of parking meters and the necessary signs and markings be, and the same is hereby authorized to be made in the above described location.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
