AN ORDINANCE EXTENDING THE PERIOD DURING WHICH THE PROVISIONS OF ORDINANCE NO. O-16332, ADOPTED NOVEMBER 20, 1984, SHALL APPLY FOR ONE YEAR.

WHEREAS, on November 20, 1984, pursuant to the provisions of Municipal Code Section 101.0205.2, the City Council enacted an ordinance entitled An Emergency Ordinance Limiting the Issuance of Building Permits and Commencement of Construction of Projects Within Council District 4, which ordinance remains in effect for 90 days from its adoption; and

WHEREAS, Municipal Code Section 101.0205.2 provides that such an ordinance may be extended for a period not to exceed one year following a noticed public hearing; and

WHEREAS, a noticed public hearing on such an extension was conducted by the Planning Commission on January 10, 1985; and

WHEREAS, a noticed public hearing on such an extension was conducted by the City Council on February 5, 1985; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Ordinance No. 0-16332 shall remain in effect until November 20, 1985 or until the effective date of an ordinance Limiting the Issuance of Building Permits and Commencement of Construction of Projects Within Southeast San Diego, whichever first occurs.

Section 2. This ordinance shall take effect and be in force immediately upon its introduction and adoption.
