AN ORDINANCE INCORPORATING THE "DALEY ISLAND REORGANIZATION" INTO COUNCIL DISTRICT NO. 5.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
