AN ORDINANCE INCORPORATING LOTS 4 AND 5, CRESTMAR PARK, MAP NO. 8802 (A 6.75-ACRE SITE, LOCATED ON THE NORTH SIDE OF CARROLL ROAD, BETWEEN CAMINO SANTA FE AND CARROLL RIDGE ROAD, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B AND M-1B (HR) ZONES, AS DEFINED BY SECTIONS 101.0435.2 AND 101.0454 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance Lots 4 and 5, Crestmar Park, Map No. 8802 (a 6.75-acre site), located on the north side of Carroll Road, between Camino Santa Fe and Carroll Ridge Road, in the Mira Mesa Community Plan area, in The City of San Diego, California, within the boundary of the districts designated "M-1B" and "M-1B (HR)" on Zone Map Drawing No. B-3657, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0435.2 and 101.0454 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into M-1B and M-1B (HR) Zones, as such

zones are described and defined by Sections 101.0435.2 and 101.0454 of the San Diego Municipal Code, the boundary of such zones to be as indicated on Zone Map Drawing No. B-3657, filed in the office of the City Clerk as Document No. 769100. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall

-attach to the said land described in Section 1 of this ordinance,

Ordinance No. 10936 (New Series), adopted October 5, 1972, of the

ordinances of The City of San Diego be and it is hereby repealed

insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
