AN ORDINANCE AMENDING ORDINANCE NO. 0-16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 0-16249-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING FROM THE CLASSIFIED SERVICE ONE (1.00) PRINCIPAL PLANNER POSITION IN THE PLANNING DEPARTMENT (065); AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, on February 26, 1985, the City Council authorized, via Ordinance No. 16378 (New Series), the addition of one (1.00) Principal Planner position to the Planning Department (065) for the purpose of serving as a Sign Code Administrator in Program 06530; and

WHEREAS, the position was added to the personnel authorization of said Planning Department Program (06530) in the Classified Service; and

WHEREAS, it has been requested that the newly authorized Principal Planner position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission has reviewed this request on March 7, 1985, and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That after receiving the March 7, 1985 review and favorable comment thereon by the Civil Service Commission pursuant to Charter section 117(a)17, that Ordinance No. 0-16249 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 00-16249-1, as adopted and amended therein, by exempting from the Classified Service one (1.00) Principal Planner (Sign Code Administrator) position in the Planning Department (065) and declaring the same to be in the Unclassified Service of The City of San Diego.

Section 2. As a schedule of compensation for the unclassified position declared in section 1 above, the salary rate set forth in Salary Rates 7.7 and 7.8 of the Table of Classifications and Standard Salary Rates under Management Category C, identified as Exhibit C to Ordinance No. 16214 (New Series), be and the same is hereby adopted.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.


