WHEREAS, the Auditor and Comptroller has reviewed the current structure of the General Accounting Division within that department for the purpose of making more efficient and streamlining the operation; and

WHEREAS, this process and objective takes into consideration the continuous demand for additional services and increase in responsibilities, as well as keeping pace with changes in accounting and reporting requirements; and

WHEREAS, the proposed personnel changes may be accomplished without any increase in the current year budget for the Auditor and Comptroller; and

WHEREAS, background and information for this budget personnel adjustment is contained in a Report to the Mayor and Council from the Auditor and Comptroller, dated March 6, 1985; and

WHEREAS, the matter is now forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 16249 (New Series), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16249-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 050, City Auditor and Comptroller, one (1) Accountant III position and one (1) Accountant I position and deleting therefrom one (1) Principal Accountant (Unclassified) position.

Section 2. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
