AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 91.02 AND BY ADDING SECTION 91.02.1213, RELATING TO ACCESS TO BUILDINGS AND FACILITIES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 91.02, to read as follows:

SEC. 91.02.1213 ACCESS TO BUILDINGS AND FACILITIES

Section 1213. Buildings shall be made accessible to the physically handicapped as required by Part 2, Title 24 of the California Administrative Code and as may be amended from time to time.

Section 3. All building permit applications filed with The City of San Diego prior to the effective date of this ordinance shall be exempt from the provisions thereof.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
