ADOPTED ON MAY 13 1985

AN ORDINANCE PURSUANT TO SECTION 99 OF THE CITY CHARTER APPROVING A MANAGEMENT AGREEMENT WITH THE SAN DIEGO UNIFIED PORT DISTRICT FOR THE MANAGEMENT, OPERATION AND MAINTENANCE OF A CONVENTION CENTER TO BE CONSTRUCTED BY THE DISTRICT ON DISTRICT PROPERTY.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That the proposed Convention Center Management Agreement (the "Management Agreement"), to be dated as of the effective date of this ordinance, which is on file in the office of the City Clerk as Document No. 00-16425, is hereby approved and the City Manager is hereby authorized to execute the Management Agreement on behalf of the City.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

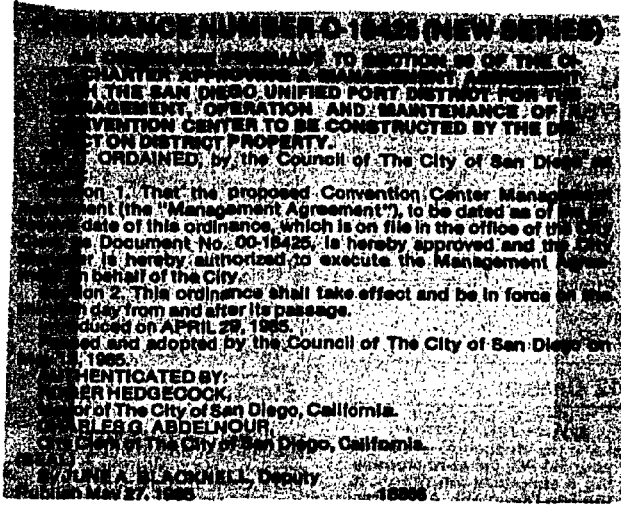
