AN ORDINANCE AMENDING CHAPTER 6, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.1005 RELATING TO LOCATION OF NEWSRACKS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter 6, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending section 62.1005, to read as follows:

SEC. 62.1005 LOCATION OF NEWSRACKS

Any newsrack which rests in whole or in part upon, in, or on any portion of a public right of way or which projects onto, into, or over any part of a public right of way shall be located in accordance with the provision of this section.

Subsections (a) through (c) - No change.

- (d) Newsracks may be placed next to each other, provided that no group of newsracks shall extend for a distance of more than ten (10) feet along a curb, and a space of not less than five (5) feet shall separate each group of newsracks.
- (e) No newsrack shall be placed, installed, used or maintained:

Subsections (1) through (9) - No change.

(10) Within five (5) feet of a curb painted blue, pursuant to the provisions of California Vehicle Code section 21458.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
