BE IT ORDAINED, by the Council of The City of San Diego that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a fifty (50) year Joint Powers Agreement with the COUNTY OF SAN DIEGO, which agreement provides for the County to design and develop a staging area, hiking trail and viewpoint in portions of Mission Trails Regional Park and for the City to maintain and operate such development, under the terms and conditions set forth in that Joint Powers Agreement on file in the office of the City Clerk as Document No. 00- 16432.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
