AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 62.0209 RELATING TO THE ESTABLISHMENT OF THE CENTRE CITY REVIEW COMMITTEE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 2, Division 2, of the San Diego Municipal Code be and the same is hereby amended by adding section 62.0209 relating to the establishment of the Centre City Review Committee to read as follows:

SEC. 62.0209 CENTRE CITY REVIEW COMMITTEE

- (a) There is hereby established a Centre City Review

 Committee. The City Manager shall, pursuant to

 administrative regulations, appoint from among City staff and

 from appropriate City owned corporations, a representative

 group of persons who will comprise the committee.
- (b) The committee shall be advisory to the City
 Manager, City Engineer, and the Planning Director in matters
 regarding improvements or encroachments within the public
 right-of-way of Centre City whenever such improvements are
 subject to the provisions of the Urban Design Program,
 including but not limited to the following:
 - 1. Light standards.
 - Sidewalk pavement.

- 3. Street landscaping.
- 4. Sidewalk cafes.
- 5. Pushcarts.
- (c) The committee shall meet at such time and place as necessary for the conduct of its business and as often as required by administrative regulation to carry out its duties.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Section 3. This ordinance shall be in full force and effect for one calendar year from the date it first becomes effective. After the expiration of one year this ordinance shall cease to be of any force and effect unless the City Council shall by ordinance extend its operation.
