
AN ORDINANCE PREZONING PARCELS 1 AND 2, PARCEL MAP NO. 7222, AND A PORTION OF QUARTER SECTION 100 RANCHO DE LA NACION, MAP NO. 166, (3.41 ACRES), LOCATED NORTH OF THE SOUTH BAY FREEWAY, BETWEEN TONAWANDA DRIVE AND WOODMAN STREET, IN THE SOUTH BAY TERRACES COMMUNITY PLAN AREA, (VALLEY ROAD ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 ZONE AS DEFINED BY SECTION 101.0407, OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcels 1 and 2, Parcel Map No. 7222, and a portion of Quarter Section 100 Rancho de la Nacion, Map No. 166, (3.41 acres), located north of the South Bay Freeway, between Tonawanda Drive and Woodman Street, in the South Bay Terraces Community Plan area, in the County of San Diego, California, within the boundaries of the district designated "R1-5000" on that certain Zone Map Drawing No. B-3714, filed in the office of the City Clerk under Document No. 769165 be, upon annexation to The City of San Diego, incorporated into R1-5000 Zone as defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of the Valley Road Annexation, whichever is later.
