
AN ORDINANCE PREZONING A PORTION OF LOT 70 AND A PORTION OF LOT C, RANCHO MISSION, CC-15191, (APPROXIMATELY 40.89 ACRES), LOCATED 16,000 FEET NORTHWEST OF MISSION GORGE ROAD, BETWEEN JACKSON AND PRINCESS VIEW DRIVES, (UPPER MISSION GORGE ANNEXATION), IN THE NAVAJO COMMUNITY PLAN AREA, IN THE COUNTY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE AS DEFINED BY SECTION 101.0404, OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 70 and a portion of Lot C, Rancho Mission, CC-15191, (approximately 40.89 acres), located 16,000 feet northwest of Mission Gorge Road, between Jackson and Princess View Drives, (Upper Mission Gorge Annexation), in the Navajo Community Plan area, in the County of San Diego, California, within the boundaries of the district designated "A-1-10" on that certain Zone Map Drawing No. B-3722, filed in the office of the City Clerk under Document No. 769188, be, upon annexation to The City of San Diego, incorporated into A-1-10 Zone as defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of the Upper Mission Gorge Annexation, whichever is later.
