ORDINANCE NUMBER O- 16478 (NEW SERIES)

ADOPTED ON JUL 29 1985

AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 8, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 68.0154(f) RELATING TO AN INTERIM CURFEW FOR AIRCRAFT LANDING OR DEPARTING FROM MONTGOMERY FIELD AIRPORT.

WHEREAS, Ordinance No. O-16276 (N.S.) adding Section 68.0154 of the San Diego Municipal Code became effective on September 19, 1984; and

WHEREAS, Ordinance No. O-16276 (N.S.) imposed an interim curfew on night operations at Montgomery Field for a period of one year from its effective date; and

WHEREAS, the City has purchased and is installing noise monitoring equipment at Montgomery Field which will permit the operation of a noise based aircraft sound monitoring system; and

WHEREAS, the sound monitoring system will be installed on September 1, 1985 which does not permit sufficient time to develop data upon which to base a new sound based ordinance before the expiration of Ordinance No. O-16276 (N.S.); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 8, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 68.0154(f) to read as follows:



(f) This ordinance shall cease to be effective from and after November 20, 1985 (14 months from its adoption) or at such time as the Noise Monitoring Program for Montgomery Field is in place and fully operative, whichever occurs first.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

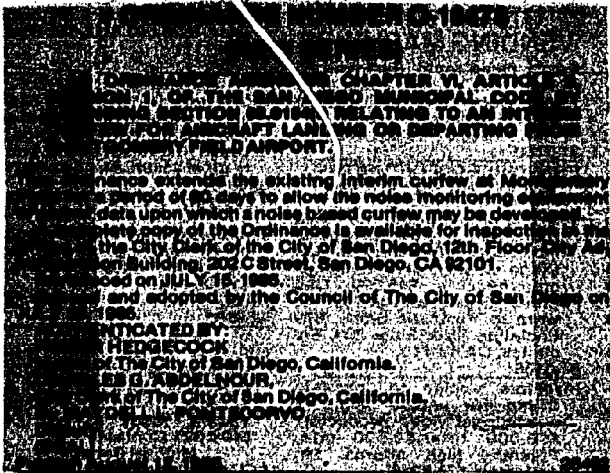


