ORDINANCE NUMBER O- 16488 (NEW SERIES)

ADOPTED ON AUG 5 1985

AN ORDINANCE AMENDING CHAPTER I, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 11.15 RELATING TO GENERAL PROVISIONS.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter I, of the San Diego Municipal Code be and the same is hereby amended by amending Section 11.15 to read as follows:

SEC. 11.15 DEFINITIONS AND INTERPRETATION

The following words and phrases whenever used in this Code shall be construed as defined in this Section unless a different meaning is specifically defined and more particularly directed to the use of such words or phrases:

(a) CITY shall mean the area within the territorial city limits of The City of San Diego and such territory outside of this City over which the City has jurisdiction or control by virtue of any Constitutional or Charter provisions, or any law.

(b) COUNCIL shall mean the City Council of this City.

(c) OATH includes affirmation.

(d) OFFICE shall mean the use of the title of any officer, employee, or any office, or Ordinance or Charter shall mean such officer, employee, office, Ordinance or

Charter of The City of San Diego, unless otherwise specifically designated.

(e) SHALL and MAY "Shall" is mandatory; "May" is permissive.

1. It is the intent of the City Council of the City of San Diego that any ordinance establishing performance standards or establishing an obligation to act upon a City officer or employee, shall not be construed as creating a mandatory duty for purposes of tort liability, if the officer or employee fails to perform his directed duty or duties.

(f) WRITTEN shall include printed, typewritten, mimeographed or multigraphed.

(g) GENDERS any gender includes the other genders.

(h) SINGULAR and PLURAL the singular number includes the plural and the plural the singular.


(i) TENSES words used in the present tense include the past and future tense and vice versa.

(j) USE OF WORDS AND PHRASES words and phrases used in this Ordinance and not specifically defined shall be construed according to the context and approved usage of the language.

(k) PERSON shall mean natural person, joint venture, joint stock company, partnership, association, club, company, corporation, business trust, organization, or the manager, lessee, agent, servant, officer or employee of any of them.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
