ORDINANCE NUMBER O- 16489 (New Series)

ADOPTED ON AUG 6 1985

AN ORDINANCE AMENDING ORDINANCE NO. O-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16475-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF DEPARTMENT 011, EXECUTIVE SERVICES DEPARTMENT IN GENERAL FUND 100, ONE (1) COUNCIL REPRESENTATIVE II POSITION; EXEMPTING SAID POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Executive Services Department has requested the addition of one (1) Council Representative II position to undertake increased workload; and

WHEREAS, said Executive Services Department has requested the exemption from the Classified Service of this council Representative II position which is herein requested to be added to its personnel allocation; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on July 22, 1985 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, to implement this request and authorize the additional position, it is necessary to amend the annual appropriation ordinance to provide such position; and

WHEREAS, funds for such additional position for the remainder of fiscal year 1985-86 currently exist in the Executive Services Department budget; and

WHEREAS, it is also necessary to amend the annual appropriation ordinance to effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16475-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 011, Executive Services Department, General Fund 100, one (1) Council Representative II position.

Section 2. That pursuant to section 117(a) of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on July 22, 1985, the Council Representative II position is hereby exempted from the Classified Service and declared to be in the Unclassified Service.


Section 3. As a schedule of compensation for the above unclassified position, the salary rate set forth in Salary Rates

7.0 and 7.1 of the Table of Classifications and Standard Salary Rates under Managerial Category A, contained in Exhibit C to Ordinance No. O-16434 (New Series), dated May 28, 1985, be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

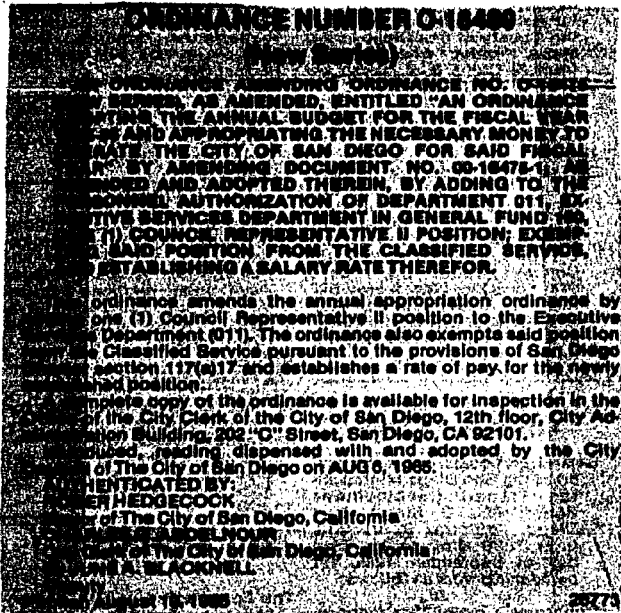
