AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING THE ORDINANCE IMPOSING BUSINESS LICENSE FEES IN THE BUSINESS IMPROVEMENT AREA OF LA JOLLA.

WHEREAS, the Council of The City of San Diego on November 13, 1978, by Ordinance No. 12486 (New Series), created the La Jolla Improvement area under the Parking and Business Improvement Area Law of 1965 (California Streets and Highways Code, Section 36000 et seq.); and

WHEREAS, the Board of Directors of the La Jolla Parking and Business Improvement Association has requested that the District be phased out of existence; and

WHEREAS, the City Manager has recommended that the La Jolla Improvement area remain in existence until its activities are completed and its funds fully expended; and

WHEREAS, the Council had adopted a resolution of intention (Resolution No. R-263667) to lower the rate of taxation to zero and given notice of the time and place of this hearing all in accordance with Section 36061 of the California Streets and Highways Code; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Sections 3 and 4 of Ordinance No. 12486 (New Series) be amended to delete all provisions for the collection of the additional taxes for the La Jolla Improvement Area.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
