ADOPTED ON SEP 9 1985

AN ORDINANCE INCORPORATING PARCELS 1 AND 2, PARCEL MAP 4420 AND A PORTION OF BLOCK A, NORDICA HEIGHTS MAP 1446 (APPROXIMATELY 0.77 ACRES), LOCATED AT THE NORTH END OF DALBERGIA COURT AT THE I-5/DIVISION STREET INTERCHANGE, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE O-15114 (NEW SERIES), ADOPTED DECEMBER 3, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcels 1 and 2, Parcel Map 4420 and a portion of Block A, Nordica Heights Map 1446 (approximately 0.77 acres), located at the north end of Dalbergia Court at the I-5/Division Street interchange, in the Southeast San Diego Community Plan area, in The City of San Diego, California, within the boundary of the district designated CA on Zone Map Drawing No. B-3711, filed in the office of the City Clerk as Document No. 769224, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428 of the San Diego Municipal Code.

Section 2. That Ordinance No. O-15114, adopted December 3, 1979, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
