AN ORDINANCE AMENDING CHAPTER V, ARTICLE 9,
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY
ADDING SECTION 59.0107 RELATING TO THE SALE
AND CATERING OF FOOD IN THE SAN DIEGO JACK
MURPHY STADIUM PARKING FACILITY.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter V, Article 9, Division 1, of the San
Diego Municipal Code be and the same is hereby amended by adding
Section 59.0107 to read as follows:


SEC. 59.0107 FOOD AND BEVERAGE CATERING IN
THE SAN DIEGO JACK MURPHY STADIUM
PARKING FACILITY

No person shall sell food or beverages or provide food
or beverages catering in the San Diego Jack Murphy Stadium
Parking Facility without a permit from the City. For
purposes of this section, the phrase "Food or beverage
catering" shall mean the serving of food or beverages to a
specific group at a specified prearranged price by a licensed
caterer.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.
