AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0631 RELATING TO SATELLITE ANTENNAS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 6, of the San Diego Municipal Code be and the same is hereby amended by adding Section 101.0631 to read as follows:

SEC. 101.0631 NOTICE OF DISCLOSURE

Any person, persons or organization that sells or installs satellite antennas for for use within the City of San Diego shall provide to the purchasers or users of such antennas a copy of the provisions of the San Diego Municipal Code that regulate the location and use of such antennas and a Notice of Disclosure form. The applicable sections of the San Diego Municipal Code and the Notice of Disclosure forms utilized shall be those provided by The City of San Diego and shall be available in the office of the Zoning Administrator of The City of San Diego.

Any person, persons or organization that sells or installs satellite antennas for use within the City of San Diego shall retain a copy of the Notice of Disclosure which has been signed by the purchaser or user of the satellite antenna and shall provide such copy for examination by The City of San Diego upon request at any time within three years from the date of sale or installation of the satellite antenna.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
