AN ORDINANCE AMENDING TEMPORARY INTERIM ORDINANCE NO. 0-16486 (NEW SERIES), LIMITING THE ISSUANCE OF BUILDING PERMITS AND THE COMMENCEMENT OF CONSTRUCTION WITHIN THE GREATER GOLDEN HILL PRECISE PLAN AREA.

WHEREAS, on July 30, 1985, the Council of The City of San Diego adopted Ordinance No. O-16486 (New Series) as an emergency measure to limit for a period of sixty days the issuance of building permits and the commencement of construction within the Greater Golden Hill Precise Plan area; and

WHEREAS, it is necessary to continue to limit the issuance of building permits and the commencement of construction an additional 75 days in the Greater Golden Hill Precise Plan area until an update of the area's precise plan is adopted; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 4 of Ordinance No. 0-16486 (New Series), adopted July 30, 1985, be and it is hereby amended to read as follows:

Section 4. This ordinance shall, for the reasons set forth in the preamble hereto, take effect and be in force immediately upon its introduction and adoption by the City Council and all the provisions thereof, including the provisions of Section 3., Paragraph D., shall be of no further force and effect 135 days from said date.
