BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article IX, of the San Diego Municipal Code be and the same is hereby amended by amending Section 59.5.0401, to read as follows:

SEC. 59.5.0401 SOUND LEVEL LIMITS

A. B. C. and D. - No change.

E. This section does not apply to noise generated by helicopters at heliports or helistops authorized by a conditional use permit.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
