AN ORDINANCE AMENDING ORDINANCE NO. 0-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16475-1, AS AMENDED AND ADOPTED THEREIN, RELATING TO THE CAPITAL IMPROVEMENTS PROGRAM BY REDUCING THE AMOUNT OF SALES TAX APPROPRIATED IN THE CAPITAL OUTLAY FUND (30245) BY \$60,906.00; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER TO AND APPROPRIATE \$60,906.00 OF SALES TAX REVENUES INTO THE GENERAL FUND (100), UNALLOCATED RESERVE (605), AND EXPEND THE SUM OF \$60,906.00 FROM THE GENERAL FUND (100), UNALLOCATED RESERVE (605), TO PAY FACILITY BENEFIT ASSESSMENT FEES DUE ON LOT 5 CAMPUS POINT BUSINESS PARK.

WHEREAS, the City Council by Resolution No. R-263985 dated September 9, 1985, approved in concept the appropriations and expenditures contained herein; and

WHEREAS, it is now necessary to effectuate this action by ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by adopting Documents No. OO-16475-1, as amended and adopted therein, by amending the

Fiscal Year 1986 Capital Improvements Program by reducing the amount of sales tax appropriated in the Capital Outlay Fund (30245), CIP 39-040 Pueblo Lands - Development by the sum of \$60,906.00.

Section 2. That the City Auditor and Comptroller be and he is hereby authorized to transfer to and appropriate into the General Fund (100), Unallocated Reserve (605), said sales tax revenues in the amount of \$60,906.00 and to further expend said amount from the Unallocated Reserve (605) to pay facility benefit assessment fees due on Lot 5 Campus Point Business Park (Facility Benefit Assessment - North University City Fund 79001).

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
