AN ORDINANCE AMENDING ORDINANCE NO. 0-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16475-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE PURCHASING DEPARTMENT (057), ONE (1) ASSOCIATE ADMINISTRATIVE ANALYST POSITION; AND TRANSFERRING WITHIN THE GENERAL FUND 100, THE SUM OF \$23,353 FROM THE UNALLOCATED RESERVE (605) TO THE PURCHASING DEPARTMENT (057), FOR THE PURPOSE OF FULLY FUNDING THE ABOVE AUTHORIZED POSITION FOR THE REMAINDER OF FISCAL YEAR 1985-86.

WHEREAS, after a management audit and study of the duties and responsibilities of the Purchasing Department, the City Manager recommended in his Report No. 85-437, dated September 4, 1985, the restructuring of departmental personnel allocations; and

WHEREAS, in connection therewith, it was also recommended by the City Manager that an additional position of Associate

Administrative Analyst be authorized for the Purchasing

Department; and

WHEREAS, said City Manager's Report No. 85-437 was reviewed by the Rules Committee on October 28, 1984 and the recommendations approved by a 4-0 vote; and

WHEREAS, the expected net effect of this restructuring would be to increase Purchasing Department efficiency and reduce turnaround time required to procure needed materials, supplies, and services; and



WHEREAS, the matter is now forwarded to the full Council for appropriate ordinance amendatory action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16475-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Purchasing Department (057), one (1.00) Associate Administrative Analyst position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$23,353 from the Unallocated Reserve (605) to the Purchasing Department (057), for the sole and exclusive purpose of fully funding the above newly authorized position for the remainder of Fiscal Year 1985-86.



Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
