AN ORDINANCE AMENDING ORDINANCE NO. O-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16475-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (130), 6.00 POSITIONS, AS SPECIFIED HEREIN; AUTHORIZING THE ALLOCATION OF THE SUM OF \$162,310 FROM THE ENTERPRISE FUND NO. 41300, UNAPPROPRIATED FUND BALANCE TO THE BUILDING INSPECTION DEPARTMENT (130), FOR THE PURPOSE OF FULLY FUNDING THE ABOVE AUTHORIZED POSITIONS FOR THE REMAINDER OF PERIOD JANUARY 1, 1986 THROUGH JUNE 30, 1986.

WHEREAS, in January 1985, a City Manager task force was established to study ways to improve the quality of the City construction permit process; and

WHEREAS, on July 8, 1985, the major findings of the study were presented to the Rules Committee and were the subject of City Manager's Report No. 85-341, dated July 1, 1985 and the Rules Committee accepted the report and directed the City Manager to respond 90 days to five specific items, including "Changes to the Building Inspection Department's FY 1986 Enterprise Fund expenditure schedule necessary to implement the recommended changes;" and

WHEREAS, these changes are discussed in City Manager's Report No. 85-523, dated October 23, 1985, including its attachment "B", which recommended eighteen new positions, the need for said

positions having been discussed in detail in City Manager's Report No. 85-341; and

WHEREAS, on October 28, 1985, the Rules Committee, in addition to deciding on a location for the Permit Center, recommended authorizing six of the new positions commencing January 1986, and the attendant expenditure of \$162,310 from the Building Inspection Department's Enterprise Fund; and

WHEREAS, the matter is now forwarded to the full Council for appropriate action; NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16475-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Building Inspection Department (130), 6.00 positions as identified and set forth in Attachment "A" hereto.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to allocate the sum of \$162,310 from the Enterprise Fund No. 41300, Unappropriated Fund Balance to the Building Inspection Department (130) for the sole and exclusive purpose of fully funding the positions authorized and set forth in Attachment "A" for the period January 1, 1986 to June 30, 1986.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
