ORDINANCE NUMBER O- 16550 (NEW SERIES)

ADOPTED ON DEC 02 1985

AN ORDINANCE INCORPORATING A PORTION OF LOT A250, AND LOTS A251 THROUGH A257, SAN YSIDRO MAP NO. 1405 (APPROXIMATELY SEVEN ACRES), LOCATED 700 FEET WESTERLY OF SAN YSIDRO BOULEVARD, BETWEEN SUNSET AND BLACKSHAW LANES, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1500 ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot A250, and Lots A251 through A257, San Ysidro Map No. 1405 (approximately seven acres), located 700 feet westerly of San Ysidro Boulevard, between Sunset and Blackshaw Lanes, in the San Ysidro Community Plan Area, in The City of San Diego, California, within the boundary of the district designated "R-1500" on Zone Map Drawing No. B-3710, filed in the office of the City Clerk as Document No. 769247, be, and it is hereby incorporated into R-1500 Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
