AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 0-16343 (NEW SERIES), ADOPTED DECEMBER 17, 1984, LIMITING ISSUANCE OF BUILDING PERMITS AND COMMENCEMENT OF CONSTRUCTION IN PORTIONS OF THE MID-CITY COMMUNITY PLAN AREA.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 7 of Ordinance No. O-16343 (New Series), adopted December 17, 1984, be and the same is hereby amended to read as follows:

Section 7. This ordinance shall continue in force until the zoning within the Mid-City Community Plan area is consistent with the Mid-City Community Plan or until June 17, 1986, whichever shall come first.

Section 2. This ordinance shall constitute an emergency interim ordinance and shall become effective immediately upon its introduction and adoption by the City Council.
