AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 5, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 75.0203 RELATING TO EQUIPMENT AND SPECIFICATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VII, Article 5, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 75.0203 to read as follows:

SEC. 75.0203 EQUIPMENT AND SPECIFICATIONS

- (a) No change.

- (f) All taxicabs shall be equipped and operated so that they may be dispatched by two-way radio communication in response to a telephone or other request for service by a prospective passenger. This requirement may not be met by use of a mobile radio telephone service unless the permit holder has obtained an exemption from the City Manager. Applications for exemptions may be granted if the applicant meets all the following criteria:

(1) The permit was issued prior to October 29, 1984;

(2) The permit holder has no more than one taxicab permit;

(3) The permit holder demonstrates that meeting the requirement will have a detrimental effect on the permit holder's business;

(4) The existing communication device installed in the taxicab is capable of effectively meeting public transportation needs.

(g) No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
