AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0506 RELATING TO CONDITIONAL USE PERMITS FOR HOUSING FOR THE ELDERLY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0506 to read as follows:

SEC. 101.0506 CONDITIONAL USE PERMIT GRANTED BY PLANNING COMMISSION

A. USE WHICH MAY BE CONSIDERED

The Planning Commission shall have the authority under conditions herein provided to permit by Conditional Use Permit the following uses in any zone, including interim zones, except as otherwise provided in paragraphs "A.1.," "A.2.," "A.6.," "A.12.," "A.14.," "A.16.," "A.17." and "A.18." of this Section:

- 1. through 13. No change.
- 14. Housing for the elderly in any residential or commercial zone subject to the standards contained within the document entitled "Locational Criteria, Design and Development Standards and Guidelines for Senior Citizen Housing Projects," on file in the office of the City Clerk as Document No. 769265.

15. through 18. - No change.

B. through F. - No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
