

ORDINANCE NUMBER O- 16561 (NEW SERIES)

ADOPTED ON DEC 16 1985

AN ORDINANCE APPROVING THE NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN AND REPEALING ORDINANCE NO. 13455 (NEW SERIES), ADOPTED MARCH 17, 1932, AND ORDINANCE NO. O-11931 (NEW SERIES), ADOPTED NOVEMBER 12, 1976, INsofar AS THE SAME APPLY TO THE PROPERTIES WHICH ARE SUBJECT TO THE NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN.

WHEREAS, the Planning Commission of The City of San Diego conducted a public hearing regarding the NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN; and

WHEREAS, after due notice, the Council of The City of San Diego conducted a public hearing on this matter wherein all persons desiring to be heard were heard; and

WHEREAS, the Council of The City of San Diego has reviewed and considered all maps, exhibits, written documents and materials contained in the file regarding this project on record in The City of San Diego and the oral presentations given; and

WHEREAS, the Council of The City of San Diego finds that the NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN is consistent with and required for the systematic implementation of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That this Council hereby approves and adopts the NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN, dated October 24, 1985, on file in the office of the City Clerk as Document No.

00-16561.

Section 2. That Ordinance No. 13455 (New Series), approved March 17, 1932, and Ordinance No. O-11931 (New Series), adopted November 12, 1976, of the ordinances of The City of San Diego be, and the same are hereby repealed insofar as they apply to the property which is the subject of the NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN.

Section 3. The provisions of Section 1 of this ordinance shall become effective upon the final adoption of the amendment of the General Plan, including the NEXUS TECHNOLOGY CENTRE SPECIFIC PLAN, or the effective date of this ordinance, whichever shall later occur.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
