ORDINANCE NUMBER O- 16563 (NEW SERIES)

ADOPTED ON DEC 16 1985

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. O-15623 (NEW SERIES), ADOPTED DECEMBER 7, 1981, INCORPORATING PARCEL MAP NO. 9470, AND PORTIONS OF PUEBLO LOTS 1303 AND 1278 (LOTS 1-20, TM 85-0533), LOCATED ON THE EAST SIDE OF TOWNE CENTRE DRIVE BETWEEN LA JOLLA VILLAGE DRIVE AND NOBEL DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1500 AND CN ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0426, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. O-15623 (New Series), adopted December 7, 1981; and

WHEREAS, Section 1 of Ordinance No. O-15623 (New Series) provided that the R-1500 and CN Zones would attach if a final map or maps were recorded on or before January 6, 1987; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Section 1 of Ordinance No. O-15623 (New Series), adopted December 7, 1981, is hereby amended to read as follows:

Section 1. That in the event that Parcel Map 9470 and portions of Pueblo Lots 1303 and 1278 (Lots 1-20, TM 85-0533) located on the east side of Towne Centre Drive between La Jolla Village Drive and Nobel Drive, in the City of San Diego, California, within the boundary of the district designated "R-1500" and "CN" on that certain Zone Map Drawing No. B-3479.1, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before January 6, 1988, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0410 and 101.0426 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R-1500 and CN Zones, as described by Sections 101.0410 and 101.0426, respectively, of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3479.1, filed in the office of the City Clerk as Document No. 769250. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
