ORDINANCE NUMBER O-16567 (New Series)

ADOPTED ON DEC 17 1985

AN ORDINANCE AMENDING ORDINANCE NO. 16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16475-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING FROM THE CLASSIFIED SERVICE, TWO (2.00) DEPUTY DIRECTOR POSITIONS IN THE BUILDING INSPECTION DEPARTMENT (130); AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, on November 26, 1985, the City Council authorized the addition of two (2.00) Deputy Director positions to the Building Inspection Department (130) for the purpose of augmenting and accommodating a reorganization to improve the City's permit process; and

WHEREAS, it has been requested that the newly authorized Deputy Director positions be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 5, 1985 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter as set

forth in its letter to the Mayor and Council, dated December 6, 1985; and

WHEREAS, it is requested that the annual appropriation ordinance be amended to effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That after receiving the December 6, 1985 review and favorable comment thereon by the Civil Service Commission, pursuant to Charter section 117(a)17, this Council directs that Ordinance No. O-16475 (New Series), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. OO-16475-1, as adopted and amended therein, by exempting from the Classified Service two (2.00) Deputy Director positions in the Building Inspection Department (130) and declaring the same to be in the Unclassified Service of The City of San Diego.

Section 2. As a schedule of compensation for the above unclassified positions declared in section 1 above, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Management Category C, contained as Exhibit C to Ordinance No. O-16434 (New Series), dated May 28, 1985, be and the same is hereby adopted.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
