

RESOLUTION No. R- 262240 (R- 85-1014)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. SAN DIEGO JANITOR SUPPLY, 2. MISSION CHEMICAL CO., 3. CAMEO PAPER & JANITORIAL SUPPLY, and 4. ZELLERBACH PAPER COMPANY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of PAPER PRODUCTS (Janitorial) as may be required for the period of one (1) year beginning December 1, 1984 through November 30, 1985, per prices on file in the Purchasing Department as follows:

1. SAN DIEGO JANITOR SUPPLY for Item 1 - Windshield Wiper Towel, Item 3 - Shop Towels, Item 4 - Hand Towels, Item 10 - Toilet Seat Covers, ½ fold, Item 11 - Toilet Seat Covers, ½ fold, Item 12 (Alternate) - Hand Towels, and Item 15 - Hand Towels (065); terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
2. MISSION CHEMICAL CO. for Item 2 - Disposable Towels; terms 2% 20 days, plus sales tax.
3. CAMEO PAPER & JANITORIAL SUPPLY for Item 5 - Hand Towels, Item 6 - Hand Towels, Item 8 - Rolled Toilet Tissue, Item 9 - Flat Toilet Tissue, and Item 13 - Creped Wipers; terms 1% 20 days, plus sales tax.
4. ZELLERBACH PAPER COMPANY for Item 7 - Cull Toilet Tissue, Item 14 - Shop Towels (K.C. 34638), and Item 18 - Hand Towels; terms 2% 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period for Items 7 and 18 only.
