BE IT RESOLVED, by the Council of The City of San Diego as follows:


Pursuant to authority conferred by and in accordance with the provisions of Section 82.19 of the San Diego Municipal Code, the following street in said City be and it is hereby declared to be a ONE-WAY STREET:

GLENFIELD STREET, FROM ITS EASTERLY INTERSECTION WITH FAIRMOUNT AVENUE TO ITS WESTERLY INTERSECTION WITH MANZANITA DRIVE, FOR ONE-WAY WESTERLY BOUND TRAFFIC.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be, and the same are hereby authorized to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
