BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by William Gregory Clarke, a licensed land surveyor, entitled "ORO VISTA UNIT NO. 3, being a subdivision of a portion of the southeast quarter of the northwest quarter of Section 34, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that the easements with the right of ingress and egress for the construction and maintenance of drainage

facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
