RESOLUTION NUMBER R- 262265

ADOPTED ON JAN 7 1985

WHEREAS, the San Diego Association of Governments (SANDAG) established a SANDAG short-term task force, via Resolution No. 85-27, dated November 16, 1984, for the purpose of recommending the general purposes and preferred organizational arrangement for an interagency task force which would attempt to develop a consensus for the various uses of the San Diego River; and


WHEREAS, said Resolution No. 85-27 included a councilmember of The City of San Diego to serve as a participant in the short-term task force; and

WHEREAS, the matter was considered by the Rules Committee on December 10, 1984 and approved by a 4-0 vote, recommending that the full Council approve the concept and proposed representative; and

WHEREAS, it is now necessary to appoint the City's representative as approved by the Rules Committee and as set forth in the SANDAG resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Councilman Ed Struiksma be and he is hereby appointed to serve as The City of San Diego's representative on the SANDAG short-term Task Force on water projects in the San Diego River.
