Lot 98 of Ridgeview Acres Unit No. 3, in the County of San Diego, State of California, according to Map thereof No. 4434, filed in the office of the County Recorder of San Diego County, December 30, 1959;

and

WHEREAS, said residential premise has been found by the Building Inspection Director to be substandard and has been found to constitute a hazard to public safety, health and welfare by reason of inadequate maintenance, dilapidation and fire hazard; and

WHEREAS, the owner of the above described property was notified by the Building Inspection Director of these findings; and

WHEREAS, on October 30, 1984, the Housing Advisory and Appeals Board at a public hearing approved said findings; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the residential premise described above is declared to be a public nuisance.

BE IT FURTHER RESOLVED, that the City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.
