office of the City Clerk as Document No. 00-16365, effective upon adoption of an appropriate amendment to the Progress Guide and General Plan for The City of San Diego incorporating the aforesaid plans following the next omnibus hearing held on the San Diego Progress Guide and General Plan.

BE IT FURTHER RESOLVED, that the applicant and/or the City of San Diego staff are hereby authorized to submit the Blackhorse Farms and Centre Specific Plan and any necessary Local Coastal Program Land Use Plan amendments to the California Coastal Commission for its approval.
