WHEREAS, this action requires an amendment to the Joint Powers Agreement; and

WHEREAS, it is now necessary and recommended that the City Manager execute a Seventh Amendment to the Joint Powers Agreement of the San Diego Association of Governments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully empowered and authorized to execute, for and on behalf of said City, a SEVENTH AMENDMENT TO THE JOINT POWERS AGREEMENT OF THE SAN DIEGO ASSOCIATION OF GOVERNMENTS (SANDAG), pursuant to the terms and conditions set forth as attachments to the letter of the SANDAG Executive Director to the various city managers, dated December 26, 1984, entitled "Joint Powers Agreement Amendment," a copy of which is on file in the office of the City Clerk as Document No. RR-262325.
