

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of ADVANCED EMERGENCY SYSTEMS is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SIX (6) MOBILE INTENSIVE CARE UNITS (Horton Model 401 Type III) at a cost of \$51,915.48 each, for a total cost of \$311,492.88; terms 2% 21 days, plus sales tax, less trade-in allowance as follows:
