2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$4,500.00 from Park Service District Fund 11221 to CIP No. 29-543 MIRA MESA COMMUNITY PARK FENCING.
3. That the expenditure of \$4,500.00 from CIP No. 29-543 MIRA MESA COMMUNITY PARK FENCING to supplement funds previously authorized by Resolution No. 261574 adopted September 17, 1984, is hereby authorized solely and exclusively for providing funds for said project and related costs.
