

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. CLAIREMONT EQUIPMENT CO., 2. MIRAMAR BOBCAT, INC. and 3. NIXON-EGLI EQUIPMENT COMPANY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SIX (6) EACH EQUIPMENT HAULING TRAILERS as follows:

- 1. The low bid of <u>CLAIREMONT EQUIPMENT CO.</u> for <u>Item 1</u> three (3) each Tilt Bed Tandem Axle, Semi-Trailers, 32,000 lb. GVW at a cost of \$9,580.85 each, for a total cost of \$28,742.55; terms net 30 days, plus sales tax.
- 2. The low acceptable bid of MIRAMAR BOBCAT, INC. for Item 2 two (2) each Tilt Bed Tandem Axle Trailers at a cost of \$4,217.48 each, for a total cost of \$8,434.96; terms net 30 days, plus sales tax.
- 3. The low acceptable bid of NIXON-EGLI EQUIPMENT COMPANY for Item 3 one (1) each Flat Bed Tandem Axle, Semi-Trailer, 50,000 lb. GVW at a cost of \$17,742.00; terms net 30 days, plus sales tax.
