
ADOPTED ON JAN 22 1985

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized and empowered to do by City Forces all the work to convert existing recreation and security lights in all City park and recreation facilities except Balboa Park and Mission Bay Park as required in connection with the conversion of lights to the more energy efficient sodium vapor lights, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$365,000.

BE IT FURTHER RESOLVED, that the expenditure of \$365,000 is hereby authorized from Capital Outlay Fund 30245 (CIP 37-315 "Conversion of Park and Recreation and Other Facility Outdoor Lighting") for the purpose of executing this work and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
