The cost of said work shall not exceed \$365,000.

BE IT FURTHER RESOLVED, that the expenditure of \$365,000 is hereby authorized from Capital Outlay Fund 30245 (CIP 37-315 "Conversion of Park and Recreation and Other Facility Outdoor Lighting") for the purpose of executing this work and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
