

RESOLUTION NUMBER R- 282358

ADOPTED ON JAN 22 1985

WHEREAS, HARRY L. SUMMERS, INC., a California corporation, subdivider of NOBEL TERRACE UNIT NO. 2, under an agreement filed in the office of the City Clerk as Document No. RR-256990, was required to install certain improvements in said subdivision; and

WHEREAS, NOBEL TERRACE UNIT NO. 2 has been sold to MAYER GROUP, a California general partnership, and the new owner will execute an amended subdivision improvement agreement and furnish new security for the faithful performance of the amended agreement; and


WHEREAS, said subdivider has requested an extension of time in which to complete the work; and

WHEREAS, the Engineering and Development Director and the City Manager have recommended that such extension of time be granted said subdivider in which to complete the required improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that HARRY L. SUMMERS, INC., a California corporation, subdivider of NOBEL TERRACE UNIT NO. 2, under that certain agreement made with THE CITY OF SAN DIEGO, on file in the office of the City Clerk as Document No. RR-256990, is hereby granted an extension of time to September 21, 1986, within which to complete the improvements required by said agreement, upon condition that within ninety (90) days of the date of adoption of this Resolution, MAYER

GROUP, a California general partnership, shall submit to The City of San Diego an amended subdivision improvement agreement and new security for the performance of the work to be done under such amended agreement.
