

BE IT FURTHER RESOLVED, that the expenditure of funds not to exceed \$20,000 from CIP No. 29-580, Ocean Boulevard - Fence, for the purpose of designing and constructing the Ocean Boulevard Fence.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to utilize appropriate City forces to construct the Ocean Boulevard Fence.
